### RIVER VALLEY WIND FARM SPALDINGTON

The 'River Valley Wind Farm' was refused planning permission by ERYC in August but it is going to an appeal. This means that an Inspector from the Planning Inspectorate at Bristol will now decide what is best for our rural landscape but local people can still have their say.

The proposal is for 6 turbines 128m to tip, at Welham Bridge, which is south of Seaton Ross across the A163. They will be visible from our parish. If passed it is possible that further development will move closer up the Foulness valley. One wind farm (5 turbines) has already been passed at Spaldington Airfield with work to begin shortly.

Should the village of Seaton Ross support Spaldington out of the precept and/or leave it to individuals to make voluntary contributions? Come to the meeting and have your say.

Spaldington Parish Council has decided that the only way to stop this area being swamped by any more wind farms is to defend the case themselves, playing a full role at the Public Inquiry with a professional team of a barrister and expert witnesses.
